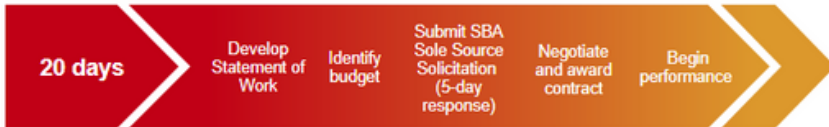

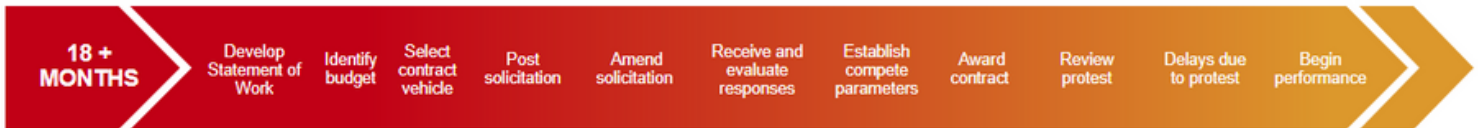
Tribal Direct contract awards can take place in as little as 20 days.
